



Cabin Rental Agreement

- **CHECK-IN TIME IS 3:00 PM. CHECK-OUT TIME IS 11:30 AM.** Two night minimum stay is required. Three night minimum stay on holiday weekends: Easter, Main Street Fest, Memorial Day, 4th of July, Labor Day and Grapefest.
- **AGE RESTRICTIONS.** Guest renting a cabin must be 21 years of age or older with photo ID. The guest under which the reservation was made must be present during check-in.
- **MAXIMUM OCCUPANCY.** A maximum of six (6) individuals per cabin rental are permitted, including those in a tent set up at a guest's cabin. One tent is permitted per cabin rental.
- **PARKING.** Guests may have a maximum of two (2) vehicles per cabin, including trailers. All parking is confined to the designated marked parking areas. Do not park on the grass. Boats and other water craft must be parked at the boat ramp parking lot. *Guests are required to provide detailed information to The Vineyards Campground for any vehicle staying at your cabin.
- **CABIN CONTENTS.** All linens, furniture and appliances are to remain in the cabin. Removal of furniture from inside the cabin or off of the deck for use on the lawn is strictly prohibited. Any items removed from the campground at check-out will be charged to the renter and/or reported to the authorities as needed.
- **CLEANING.** Maid service is not provided. If housekeeping is needed please contact the Gatehouse. Please wash and place all dishes and utensils in cabinets prior to check-out. A \$50 service fee will be charged to the guest for dishes left in the sink to be cleaned by staff. Please deposit all trash and unused refrigerator items in the nearby trash receptacle prior to check-out. Fees will be assessed for any excessive cleaning required as a result of the guest.
- **DAMAGES.** The guest is responsible for any intentional or accidental damages caused by guest or their party. Repair or replacement of damaged property will be billed to the guest accordingly. Please report damages or maintenance issues to the Gatehouse immediately so we have time to make repairs for you or the next guests arriving.
- **SANITATION.** Trash and Recycling dumpsters are provided throughout the campground. If a dumpster is full, please use one of the other dumpsters provided. Guests may not flush anything down the sink or toilet other than toilet paper. Items including, but not limited to, feminine hygiene products, condoms, napkins, paper towels, food scraps or grease are to be disposed of in the trash receptacles provided.
- **SMOKING.** All cabins and buildings at The Vineyards Campground are NON-SMOKING. Please dispose of cigarette butts in the trash or designated receptacle provided at your cabin. Do not dispose of cigarette butts on the ground or lake.
- **PETS.** Pets are not permitted inside cabins or buildings. Guests who bring pets into a cabin or building will be asked to promptly remove them or forfeit their reservation.
- **CHILDREN'S SAFETY.** Observe posted speed limits and watch out for children at play. Children must be supervised on all docks and playground. Children under 12 are not to be left unattended in any cabin, building or campsite at any time and must be accompanied by an adult age 18 +.
- **QUIET HOURS & KEYS.** Quiet hours are from 10:00 PM to 7:30 AM. All visitors must exit the campground by 10:00 PM. Return keys to the Gatehouse upon check-out. Lost keys will be billed to the renter at \$25 per key.
- **PERSONAL ITEMS.** The Vineyards Campground is not responsible for lost or stolen items. Report any missing items to the Camp Store. Found items are held at the Camp Store for 30 days.
